

**MEMORANDUM OF AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into by and between:

ROTARY CLUB OF MARIKINA HEIGHTS, R. I. DISTRICT 3800, a service organization composed of volunteer members with postal address at Marikina Hotel, Tangerine Street, Concepcion 2, Mari kina City, herein duly represented by its Club President, Ms. BUHAY S. ASTUDILLO, hereinafter called the FIRST PARTY.

GLOBAL E- BUSINESS OUTSOURCE, INC, an entity duly organized and existing under Philippine laws, with postal address at Penthouse, West City Plaza Bldg., 66 West Avenue, Quezon City, herein duly represented by its President, Ms. GEORGINA PINEDA, hereinafter called the SECOND PARTY.

**WITNESSETH: THAT**

I. WHEREAS, ROTARY INTERNATIONAL, DISTRICT 3800, thru its DG FERDINAND “FERDI” V. FUENTES, of which the FIRST PARTY is one of the affiliated Clubs, has launched a job placement program known as the DISTRICT LIVELIHOOD PLACEMENT REGISTRY where the lists of available manpower are posted;

II. WHEREAS, the FIRST PARTY has been authorized by the District to enter into an agreement with the SECOND PARTY and act as CONDUIT in matching this list of available manpower with the requirements of the SECOND PARTY to Make Dreams Real for our marginalized people;

III. WHEREAS, the FIRST PARTY is one of the Rotary Clubs commissioned by District 3800 to assist in the compilation and listing of this available manpower in their respective areas of jurisdiction including the lists that will be provided by the local government units, barangays and their Rotary Community Corps:

NOW, THEREFORE, for and in consideration of the foregoing premises, the FIRST PARTY and SECOND PARTY have agreed to mutually cooperate towards this end with the FIRST PARTY acting as the CONDUIT by providing the lists of available manpower in its Registry to the SECOND PARTY and the latter will extend its assistance and full cooperation in providing job opportunities to these workers in need of job placements, provided that the FIRST PARTY shall not in any way be considered as an employer or job placement agency but shall merely act as a conduit, hence, would not in any way be held liable for any harm, injury or damages that may be caused to these prospective employees and their eventual employers by virtue of this arrangement or agreement.
